The manual contains (a) an explanation of how QWFC will conduct the process of certifying your QU and (b) the standards that you will have to conform with. A copy of this form will therefore be forwarded to the Welsh Government in order for them to be able to process an application for CPH Number for your QU. It will also be shared with the Animal & Plant Health Agency (APHA) who will be undertaking in-use inspections of the QU.

The cost of certification is specified in the Scheme Fees Leaflet. Payment can be made by cheque, direct debit or credit card. If you are a member of the FAWL or Welsh Organic Scheme and have an active direct debit mandate in place, you may wish to use that facility to pay.
